**Early Childhood Services (937) 328-2680**

Intervention staff provides services for children age birth through five who have developmental delays. Staff has special training to assist babies and toddlers with a variety of needs including hearing and vision loss, autism, language delays and more. This program is highly effective, with 50% of the children no longer needing services upon entering kindergarten.

**Intake/Eligibility**

County Board services are voluntary and eligibility determination is required. To initiate the eligibility process for ages 5 and above call (937) 346-0754

**Community Living Services (CLS) (937) 328-2683**

Assists individuals out of school to end of life to identify needs and goals to help them live, work, and participate in our community. Link adults to other agencies such as adult day programs. Individuals receiving services are assigned a Service and Support Administrator (SSA) who serves as their primary point of coordination.

**Community Connection and Employment (CCE) (937) 328-2683 ext. 5825**

Assist children ages 6- high school and work with families and children as they advance through the educational system. Link families to community services. Individuals receiving services are assigned a Service and Support Administrator (SSA) who serves as their primary point of coordination.

Community Navigators develop creative opportunities for children-adulthood specific to engagement and employment in the community.

**SSA On Call -After Hours (937) 536-8825**

**F.F. Mueller Residential Center (937) 328-2685**

Assists residents with 24-hour nursing care funded through the Developmental Disabilities of Clark County tax levy and Medicaid.

**Transportation (937) 328-5240**

Staff transport individuals to work and community sites.

**Investigative Services (937) 328-5240**

Staff monitor and investigate situations in order to maintain safe living conditions for individuals.
